## Moe's Boarding Kennel Policies and Contract

\*\*\*\*Please Read and Initial Where Indicated\*\*\*\*

1. \_\_\_\_\_ The Owner specifically represents that they are the valid and lawful owner of the dog, and that the Owner has accurately and fully responded to each question posed in the questionnaire that precedes this contract, and forms part of this contract.
  
2. \_\_\_\_\_ The Owner agrees that they will arrange for complete vaccine information will be provided to Moe's Boarding Kennel directly by their veterinarian prior to the start date of the dog's stay. The dog will not be allowed to stay if complete vaccine information has not arrived from the veterinarian.
  
3. \_\_\_\_\_ The Owner warrants and represents that the dog is not a show dog and does not participate in dog shows. The Owner further represents that the Owner generates no income or revenue from the dog's performance. The Owner does not intend, plan, or anticipate that this dog will generate revenue or income in the future.
  
4. \_\_\_\_\_ The Owner agrees that Moe's Boarding Kennel may change the dog's boarding or daycare type if we believe it is necessary to protect the health and well-being of your dog, other dogs, or our staff. The Owner shall pay any additional costs associated with the change.
  
5. \_\_\_\_\_ If your dog becomes ill or injured, Moe's Boarding Kennel is authorized, at its sole discretion, to engage the services of a veterinarian at a cost of up to and including \$1,000.00. The Owner shall be solely responsible for all costs or charges for veterinary services.
  
6. \_\_\_\_\_ If your dog becomes ill or injured, and the illness or injury requires emergency treatment to save the dog's life or quality of life in the opinion of the veterinarian, and the owner or emergency contact cannot be reached at the time to instruct the veterinarian, then Moe's Boarding Kennel shall be entitled to authorize the emergency treatment, regardless that the treatment may exceed \$1,000.00. The Owner shall be solely responsible for all costs or charges for veterinary treatment and services.
  
7. \_\_\_\_\_ The Owner agrees that all charges for their dog's stay, including requested special service options and other costs as may be applicable pursuant to this agreement, shall be paid in full upon the end of their dog's stay, and that the dog shall not be released back to the Owner until all charges are paid in full. It shall not be construed as a waiver of payment by Moe's Boarding Kennel should Moe's Boarding Kennel choose to release a dog prior to receiving full payment of all costs.

8. \_\_\_\_\_ A dog that is unclaimed at Moe's Boarding Kennel for ten (10) days beyond its scheduled end date without having made arrangements with Moe's Boarding Kennel for the additional stay is considered abandoned, and will become the property of Moe's Boarding Kennel. If, for any reason, a dog is not going to be picked up on the scheduled end date, the Owner shall contact Moe's Boarding Kennel to make arrangements to extend the dog's stay and will pay the additional charges for the stay based on the daily rates.

9. \_\_\_\_\_ Moe's Boarding Kennel does not assume and shall not be held responsible for any loss or damage to the dog, or caused by the dog, while the dog is staying at Moe's Boarding Kennel. The Owner agrees to release and hold harmless Moe's Boarding Kennel, the owner of Moe's Boarding Kennel, and employees of Moe's Boarding Kennel from any and all manner of damages, claims, loss, liability, costs or expenses arising from such loss or damage, except where such losses arise directly as a result of gross negligence, or intentional misconduct, on the part of Moe's Boarding Kennel, the owner of Moe's Boarding Kennel, or the employees of Moe's Boarding Kennel. The Owner shall indemnify Moe's Boarding Kennel, the owner of Moe's Boarding Kennel, and/or the employees of Moe's Boarding Kennel for any costs or expenses incurred by Moe's Boarding Kennel, including but not limited to legal expenses, should a claim be brought by the Owner against Moe's Boarding Kennel contrary to this Agreement.

10. \_\_\_\_\_ This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta, Canada.

11. \_\_\_\_\_ This Contract constitutes the entire agreement between the Owner and Moe's Boarding Kennel.

12. \_\_\_\_\_ Should any dispute arise between Moe's Boarding House and the Owner regarding any portion of this Contract, the parties shall be obligated to engage in good-faith negotiations via mediation prior to filing a claim with the Court.
